# TRANSGENDER POLICY

## **POLICY:**

Booth University College is committed to providing a welcoming and inclusive environment for its students, staff and faculty. Transgender students are accommodated according to the gender they identify with and are supported in that identity. Booth University College recognizes that all situations will be unique and that the implementation of this policy will require collaboration between the student and Booth University College. Faculty and staff will use the name and pronoun that was specified by the student on their application form and keep the person's transgender status confidential. Booth University College has a zero tolerance for harassment, bullying, discriminatory language, violence, sexual assault, and any other behaviours that undermine transgender student's feelings of safety and dignity within the University College.

### Definition

A "transgender" person is a person whose gender identity or gender expression does not match the sex assigned to them at birth. "**Transgender**" is an umbrella term that includes:

- People who identify as "male" or "female". For example, a person who was assigned male at birth, but identifies as female, is a trans woman or transgender woman. MTF is the acronym for Male-to Female. A person who was assigned female at birth, but identifies as male, is a trans man or transgender man. FTM is the acronym for Female-to-Male.
- People who identify as genderqueer, two-spirited, or gender non-conforming. For example, people
  who identify as both male and female; people who identify as having no specific gender; people
  who identify as belonging to a "third gender"; and people who identify somewhere along the gender
  spectrum between male and female. The term "two-spirited" is culturally specific to North
  American Indigenous communities and refers to queer Indigenous people who identify with both a
  male and female spirit. This term is not exclusive to gender identity, and can also refer to sexual
  orientation.

Transgender is an adjective and should never be used as a noun. For example, instead of saying: "X is a transgender", say: "X is a transgender person".

# TRANSGENDER POLICY

## **Procedures**

## 1. Collecting Information:

- All students will be asked what name and which gender pronoun they prefer on their application form.
- This will be communicated to faculty and staff.
- Assumptions about a person's gender identity will not be made.

# 2. Confidentiality

Faculty and staff will use the student's name and pronoun specified by the student in all interactions, as well as when discussing the student with other faculty or staff. Faculty and staff will not disclose the student's transgender status, unless the student has provided clear permissions to do so and for only that purpose or within that context.

### 3. Harassment and Violence

Booth University College has zero tolerance for harassment, bullying, discriminatory language, violence, sexual assault, and any other behaviors that undermine transgender clients' feelings of safety and dignity with the University College.

### 4. Washrooms

Students will have privacy when using washroom facilities.

### 5. Resident Students

- Will use the sleeping area that they identify as matching their gender identity and as supporting their safety and dignity.
- Booth University College will share the available options with the student and ask where they would feel most comfortable sleeping.
